



## MARTON GOLF CLUB MEMBERSHIP CATEGORIES 2018

### Men's and Ladies subscription rights and conditions:

<b>Full Playing:</b>	Full playing and voting rights
<b>Full Playing Country:</b>	Must reside 35km or more from course. Full playing and voting rights.
<b>Dual Member:</b>	Any person who is a full member of another club and who has not been a member of this club during the last five years. No voting rights.
<b>Nine Hole:</b>	May play 9 holes on any day of the week. Tournaments and Saturdays at the discretion of the Club Captain. Voting rights.
<b>Students 19 &amp; Under 23:</b>	Over the age of 19 and under the age of 23 on 1 March. Full playing rights. Voting rights.
<b>Junior Under 19:</b>	Must be under the age of 19 on 1 March. Full playing rights. Voting rights.
<b>Summer:</b>	Full playing rights between 1 <sup>st</sup> November and 31 March. No voting rights.
<b>Non-playing:</b>	Social Member. Play restricted to Mixed Opening and Closing days. No voting rights.
<b>Remote Location:</b>	Must reside 100km or more from the course. Full playing rights.
<b>Associate:</b>	Must pay affiliated green fees. Cannot have been a member of any other category within the past 12 months. May play tournaments

1. Subscriptions are set each year at the A.G.M. and are due on the 1<sup>st</sup> April. Unpaid subs as at 31<sup>st</sup> May, where no payment arrangements have been made with the Membership officer (refer clause 2), will incur the following
  - a) A 10% penalty.
  - b) Playing rights removed along with handicap details until the subscription is paid in full, including the penalty charge.
2. Membership categories of Full Playing, Country and Nine Hole can pay by instalments under the following conditions:
  - a) Payment arrangements are to be made direct to the Membership Officer.
  - b) A minimum 25% must be made by 31<sup>st</sup> May.
  - c) The balance can be paid by instalments providing the full subscription is paid by 30<sup>th</sup> November.

- d) A \$20.00 administration fee will be added to the applicable subscription if this option is taken up.
3. The committee shall have the power to remit up to half the first year's annual subscription of a newly elected member. This excludes Remote, Dual and Associate members.
  4. Associate Membership. This category would provide the member with ability to maintain a handicap. They would pay affiliated green fee rates each time they played golf. The following conditions would apply.
    - a) An Associated Member cannot have been a member of any other category the previous season (except Non\_Playing).
    - b) A member cannot exceed 5 years of Association Membership.
    - c) If an Associated Member chooses to join either Full Playing, Country or Nine Hole, their sub would be discounted by \$25% for that first season.
    - d) All applications for membership change to this category must be in writing to the MGC Committee and approved on a case-by-case basis.
  5. A member joining after 30 September will pay half the applicable subscription for all categories, except summer membership. Remote location category will pay half fees from 1<sup>st</sup> January.
  6. A Summer Member who goes on to become a Full Playing member the following season, and hasn't been either a Full Playing, Country or Nine Hole member in the last three years, will have 50% of their Summer subscription deducted from the following season's full playing subscription.
  7. At the discretion of the Committee, a golfer visiting the district may be admitted as Part Member paying a subscription monthly rate of 10% of the annual subscription.
